## **COVID-19 Update: 40% of Lake County Residents Now Vaccinated**

*70% is our Goal, and ALL Residents Age 16+ Are Now Eligible - <https://MyTurn.ca.gov>*

**Lake County, CA (April 16, 2021)** — New cases of COVID-19 have continued to be quite low in Lake County, which allowed us to move into the less restrictive Orange Tier of the State’s “Blueprint for a Safer Economy” this week: <http://www.lakecountyca.gov/Government/PressReleases/OrangeTier041321.htm>

### **Vaccination Update: 60% of Lake County Residents Not Yet Protected by the Vaccine**

Presently, about 40% of the county’s population is at least partially vaccinated. This means 60% are not vaccinated at all. Although we are definitely moving in the right direction, we must continue to protect one another by wearing masks and practicing appropriate hygiene and social distancing. Our goal is to reach a fully vaccinated threshold of 70% of the county population, and we currently have a VACCINE SURPLUS! Please get vaccinated!

### **Concerned about vaccine safety? Please reach out to get your questions answered!**

Also, feel free to call 707-263-8174 for further information. An estimated 77 million Americans have now received two doses of vaccine. So far, severe reactions have been extremely rare. COVID-19 vaccines are very safe, and thus far effective against even emerging variants.

### **Vaccinated People Now Enjoy More Freedoms in California**

Yesterday (4/15), the State distributed new Guidance for Gatherings and Fully Vaccinated people. Fully vaccinated people are able to move about more freely, and can now gather with other vaccinated people without wearing masks:
