VICIOUS ANIMAL ABATEMENT ORDER

YOU ARE HEREBY notified that the Lake County Animal Care & Control Director and Lakeport Police Chief has determined that you are the owner/possessor of a VICIOUS ANIMAL(s) which is (are) described as:

1. Canine, German Shepard mix, Male, Black/Tan, Male, Neutered, "Bane"
2. Canine, Pitbull mix, Male, Blue/White, Male, Neutered, "Bandit"

The vicious animal is (are) located at: 563 Second St, Lakeport Ca, 95453

The findings of the investigation are as follows:

1. 05/07/21 Animal Control received a complaint of 2 loose K9s attempting to attack ducks on a property where they had previously killed a rabbit and attacked chickens. K9s identified as "Bane" and "Bandit"(Complaint #822)
2. 04/21/21 Animal Control received a complaint of 2 loose K9s having attacked and killed a cat and breaking through a person's fence, attacking and killing a chicken. K9s identified as the K9s living at 563 Second St, "Bane" and "Bandit". (Compliant #738, Citation #16891)
3. 02/16/21 Animal Control received a complaint of 2 loose K9s returning to a property where they had previously killed a rabbit and attacked a chicken. Video of "Bane" and Bandit" on property shown to ACO (Complaint #479, Citation#16887)
4. 01/20/21 Animal Control Received Complaint of 2 loose K9s returning to property where rabbit was killed. K9s were identified as "Bane" and "Bandit" (Complaint#341)
5. 01/19/21 Animal Control Received complaint of loose K9 at Park Place Restaurant. When the officer arrived, the K9 was identified as "Bane". The officer was unable to catch the dog, but when she arrived at the D/O address the dog came back shortly after. K9 was contained by D/O son. (Complaint #332, NOV #96584)

6. 12/31/20 Animal Control received complaint of stray K9 at Renee's Café, when the officer impounded the K9, it was identified as "Bane". K9 was acting aggressively towards the officer while she was trying to impound him. (Complaint #250)
7. 07/14/20 "Bane" impounded by Lakeport Police as he and "Cissy" had been loose. "Cissy" was hit by a car and was brought to AC deceased.
8. 06/19/20 Animal Control received complaint of 2 loose K9s returning to property where they had previously killed a rabbit and attacked a chicken. "Bane" and "Cissy" identified as offending K9s (Complaint #2020-06-0064, Citation # 16883)
9. 06/16/20 Animal Control received complaint from Lakeport PD regarding 2 loose K9s killing rabbits. Later Identified as "Bane" and "Cissy" (Complaint # 2020-06-0054)
10. 04/30/2020 Animal Control Received a complaint of 2 loose K9s breaking through a rabbit pen and killing the RPs rabbit. K9s later identified as be "Bane" and "Cissy" (Complaint # 2020/04/0070)
11. 02/19/20 While on patrol Deputy Director Leishman and ACO Del Fiorentino located a loose dog. The dog was followed back to 563 Second St, where the D/O was given a verbal warning for At Large and K9 was identified as "Bane".

Vicious Animal Defined by Lakeport City Code Section 6.32.020:

1. An attack, without provocation which requires a defensive action by any person to prevent bodily injury and/or property damage in a place where such person is conducting himself lawfully and peaceably.
2. An attack, without provocation, on another animal or livestock which occurs off the property of the owner of the attacking animal.
3. An attack, without provocation, that results in an injury to a person in a place where such person is conducting himself peaceably and lawfully.
4. Any behavior, without provocation, that constitutes a physical threat of bodily harm to a person in a place where such person is conducting himself peaceably and lawfully.

Therefore, the Director of Animal Care & Control and Lakeport Police Chief has imposed the following conditions:

1. Permission from property owner to maintain a Vicious Canine at this location.
2. Written proof (a true copy) of a public liability policy in the single incident amount of \$50,000 for bodily injury or death of any person(s) or for damage to property which may result from ownership or maintenance of such animal. Such insurance policy shall provide that no cancellation of the policy be made unless ten (10) days written notice is first given to the Lake County Animal Care & Control Department.
3. Posting of "Beware of Dog" signs on all sides of the property.
4. Obtain and keep current at all times, a City of Lakeport dog license and rabies vaccination.
5. Construction of a 10'x10'x6' chain link kennel with concrete floor, padlocking gate and solid roof to provide shelter from the elements and confinement of said canine. This kennel needs to be located in a secure area of the property so that members of the public cannot obtain access.

6. Allow right of entry for inspection of kennel facilities and canine by Lake County Animal Care and Control and Lakeport Police at any time.
7. Canine(s) is only allowed off of property for necessary medical appointments, and at no other time shall it be allowed off the property.
8. Photographing of canine(s) for identification purposes.
9. Canine(s) to be kept at **563 Second St, Lakeport Ca.** Animal Care & Control and Lakeport Police will be notified within 10 days of any change in ownership or residence to include new address, phone, and/or owner if ownership is transferred.
10. To be transported for vet appointments only, canine(s) shall be muzzled and on a six foot (6') maximum leash, with a responsible adult over the age of 18 years in control of that leash at all times.

YOU ARE FURTHER NOTIFIED that you must comply with the Abatement Order within 5 (five) days of this notice or file a request for a hearing before the Lakeport City Council. Filing a timely appeal will result in a stay of the Abatement Order, until a determination is made by the Lakeport City Council pursuant to Code Section 6.32.070 of the Lakeport City Code.

If after 5 (five) days the Lake County Animal Care & Control Department has not received proof of compliance with the Abatement Order or notification that an appeal has been filed, the Animal Care & Control Department will take possession of the animal and dispose of it as necessary, up to and including euthanasia.

**FAILURE TO COMPLY WITH AN ABATEMENT ORDER
ONCE ESTABLISHED**

In the event that an owner or possessor fails to comply with an Abatement Order, The Animal Care & Control Director may take one or more of the following actions:

1. Issue a citation to the owner/possessor for a violation of the above code section. Each day that a violation occurs is a separate offense.
2. Refer the matter to the District Attorney, City Attorney, or County Counsel for prosecution of the alleged violation or for the abatement of the public nuisance.
3. Impound the animal in accordance with City Code. The owner/possessor may redeem an impounded animal prior to its final disposition by the Animal Care & Control Director provided that the owner/possessor agrees to comply and is able to comply with the Abatement Order and has paid all applicable fees and charges. In the event the owner/possessor does not file a timely appeal or redeem the impounded animal within 14 (fourteen) days after a written notice has been sent to the last address of the owner as shown on the abatement record, notifying said owner that said vicious animal will become the property of the County of Lake and will be humanely destroyed unless redeemed within fourteen (14) days after the mailing date of the notice, the Animal Care & Control Director shall humanely destroy the subject vicious animal. Said written notice shall also advise the owner/possessor of their right to a hearing and an opportunity to be heard on the question of whether the animal should become the property of the County of Lake and be humanely destroyed. The notice shall be served upon the owner/possessor either personally or by registered mail, return receipt requested.

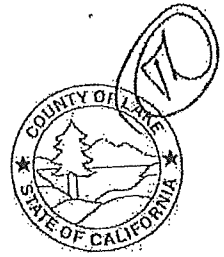

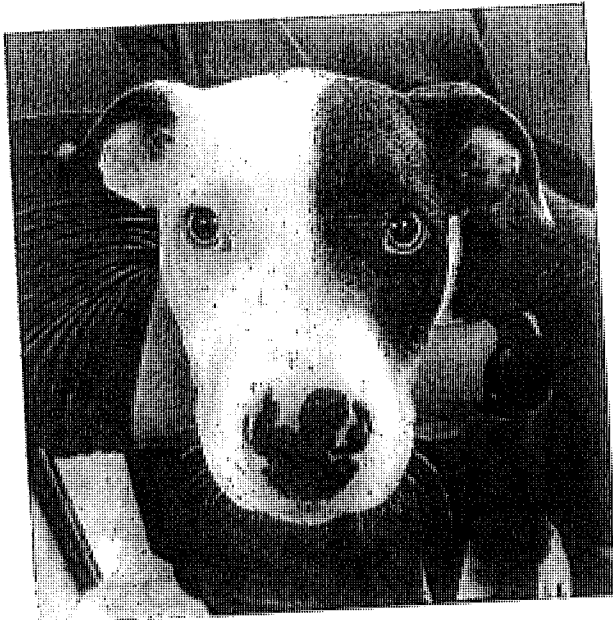

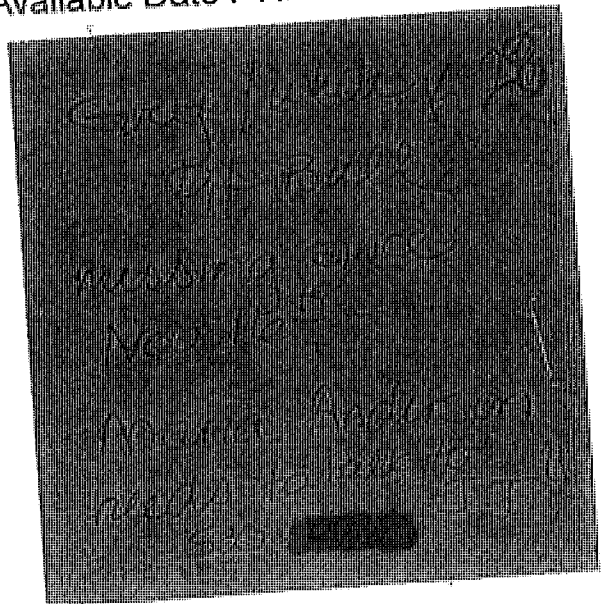

They do not want this happening again and would prefer an owner being found. In one of the pictures the black and brown GSD type breed is an unaltered male and the white and black bull type breed has a lactating under belly so she likely has reared a litter recently and is not spayed. I could not locate the dogs while on patrol-(#284).K9 owner identified on 6/19/2020. D/O stated that neither were altered. Narrative: On April 30, 2016 Officer Gonzalez received a complaint about 2 loose dogs at [REDACTED] Eleventh St. in Lakeport. She took verbal statements from the RPs along with photos and video. On 6/19/2020 I received a complaint of the same two dogs on the property, when I arrived I was unable to locate the K9s. I was able to identify the dog owner as a Maria Rose Anderson of [REDACTED] Second Street. At approximately 0955 I arrived

at her residence with Officer Gonzalez. At that time the 2 K9s were still currently at large. Though speaking with the owner I was able to confirm that neither "Bane" a 1+Yr GSD and "Sissy" an 18Mo Dalmatian/ Hound Mix were in fact altered and that they were at large quite often. Citation #16883 issued for Vicious At Large Lakeport Code 6.12.030C x2 and Failure to Spay/Neuter Lakeport Code 6.24.090 x2. Witness statements from the victims will be attached.

I was able to muzzle him for his intake process. He was not microchipped. Turns out that on June 19th 2020 D/O was issued a Citation#16883 for Bane and Sissy. 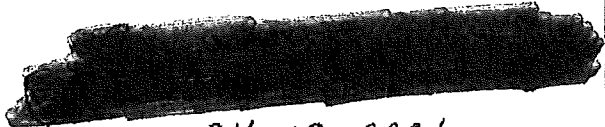

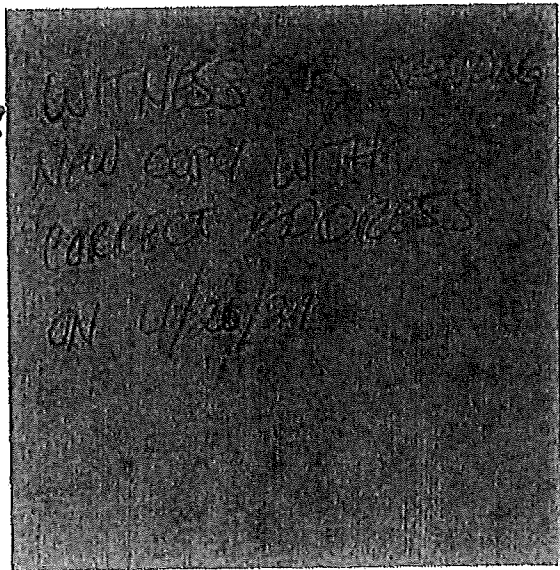
I called Animal Care on April 16, 2021, to report two loose canines. (See attached image) These two dogs had previously attacked, mauled and killed my eight (8) year old daughter's cat. A cat we had adopted from Animal Care less than six months prior. The attack on our cat occurred approximately two weeks ago. I did not know where the dogs lived and was not able to contact the owners at that time. This attack occurred in the late evening. People in the neighborhood have seen these dogs roaming around for at least several weeks prior to the attack our cat. A neighbor also witnessed the attack and attempted to scare the dogs away using a water hose; however, it was too late.

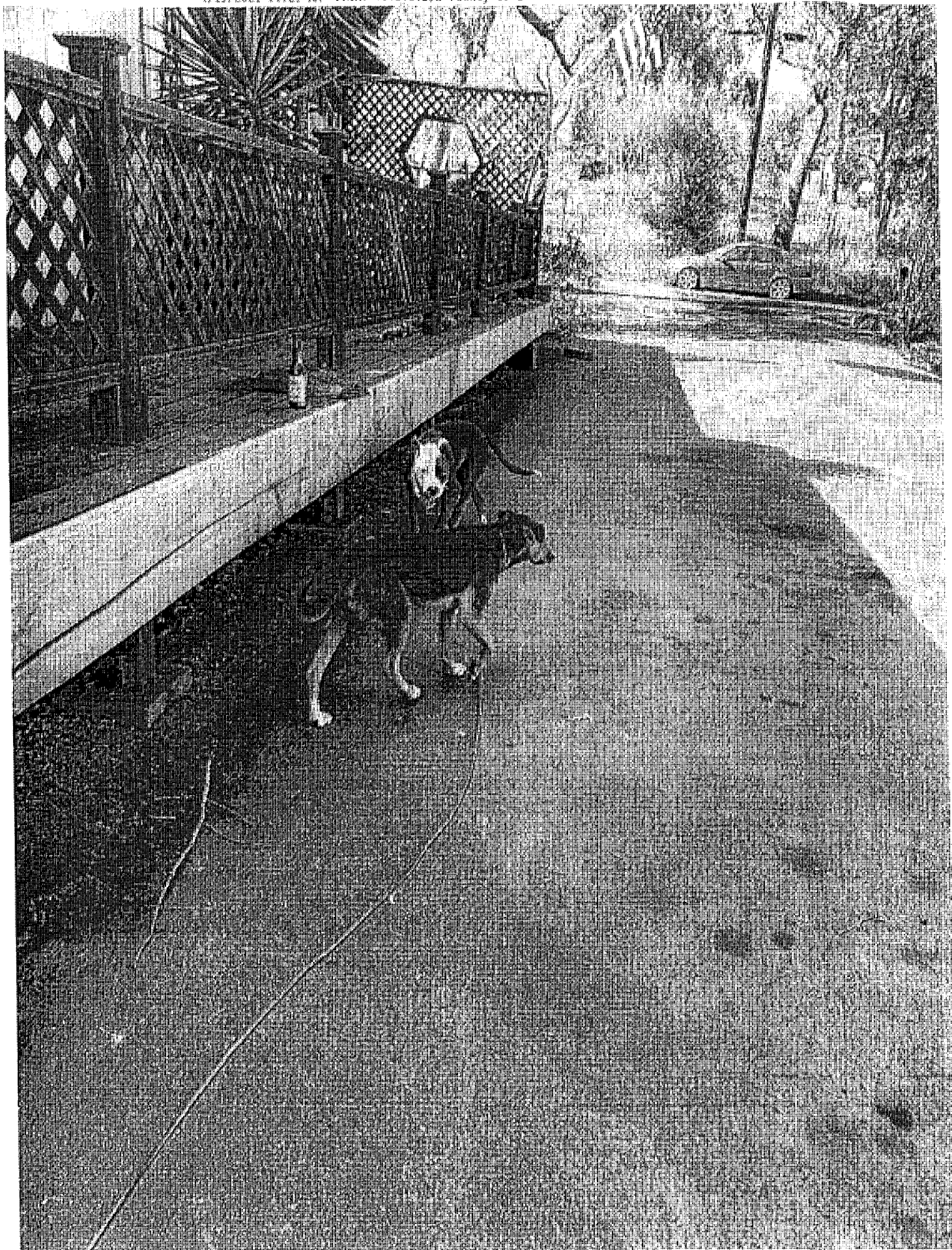
On April 16, 2021, I observed the dogs roaming down Sixth Street in Lakeport, about one block from my residence. I followed the dogs home. While they were running loose, I observed them attempt to attack another cat on Brush Street. The cat was able to escape under a house. As the dogs neared their home, I observed them attack a chicken at a Second Street residence. The grey and white (possible pit bull mix) dog had the chicken in his mouth and was thrashing it about. The homeowner ran outside in an attempt to save his chicken. He reported the dogs are often loose and he has confronted the dogs' owner numerous times.

The dogs' owner resides at [REDACTED] Second Street, Lakeport. I attempted to make contact with the owner; however, there was no answer and it not appear anyone was home. There did not appear to be a way for me to secure the animals.

Just to clarify my voice mail message, I ran a search in LPD records and LCSO Dispatch records for [REDACTED] Second Street, from January 1, 2018 through May 7, 2021 and did not find any responsive records to your request.

In addition I ran a search for Anderson, Marie in the LPD Data Base and LCSO Dispatch records and did not find any responsive records.

I also checked our Pet License data base and found no canines licensed to a Marie Anderson.

The only record I found was the informational incident of when Officer Trouette brought the deceased canine to your agency that had been hit by a car on 11th street. If you would like a copy of that report, please let me know. LPD# 20070428

It is possible that there may have been calls regarding these animals, but if the calls did not generate some kind of response in relation to [REDACTED] 2nd Street, or Marie Anderson, then such a record would be difficult to find. For example, someone called and reported a dog causing issues on 11th street, and our officer's responded, and were able to contact the owner come pick it up, the owners name might not have been put in the system, and the call was closed out as General Services. 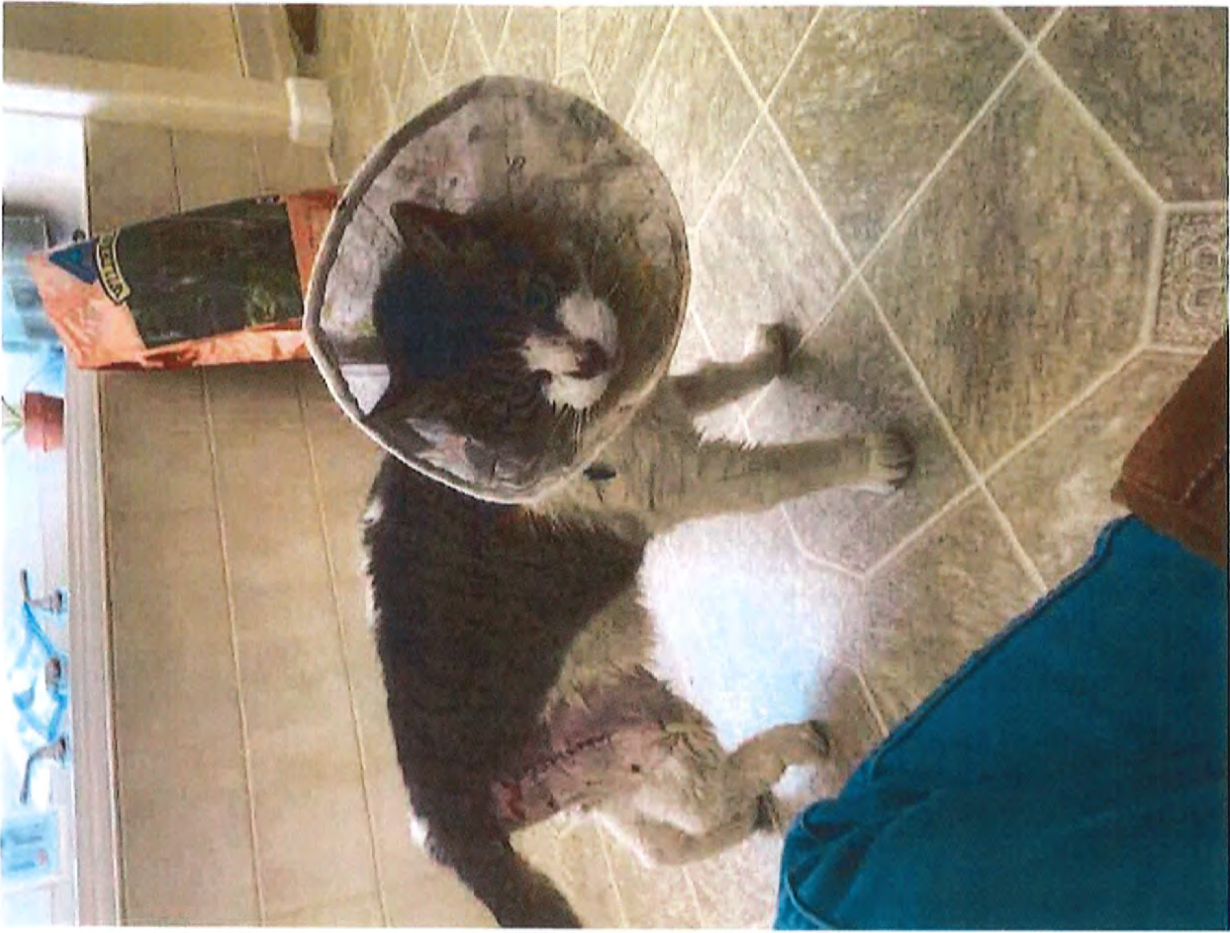

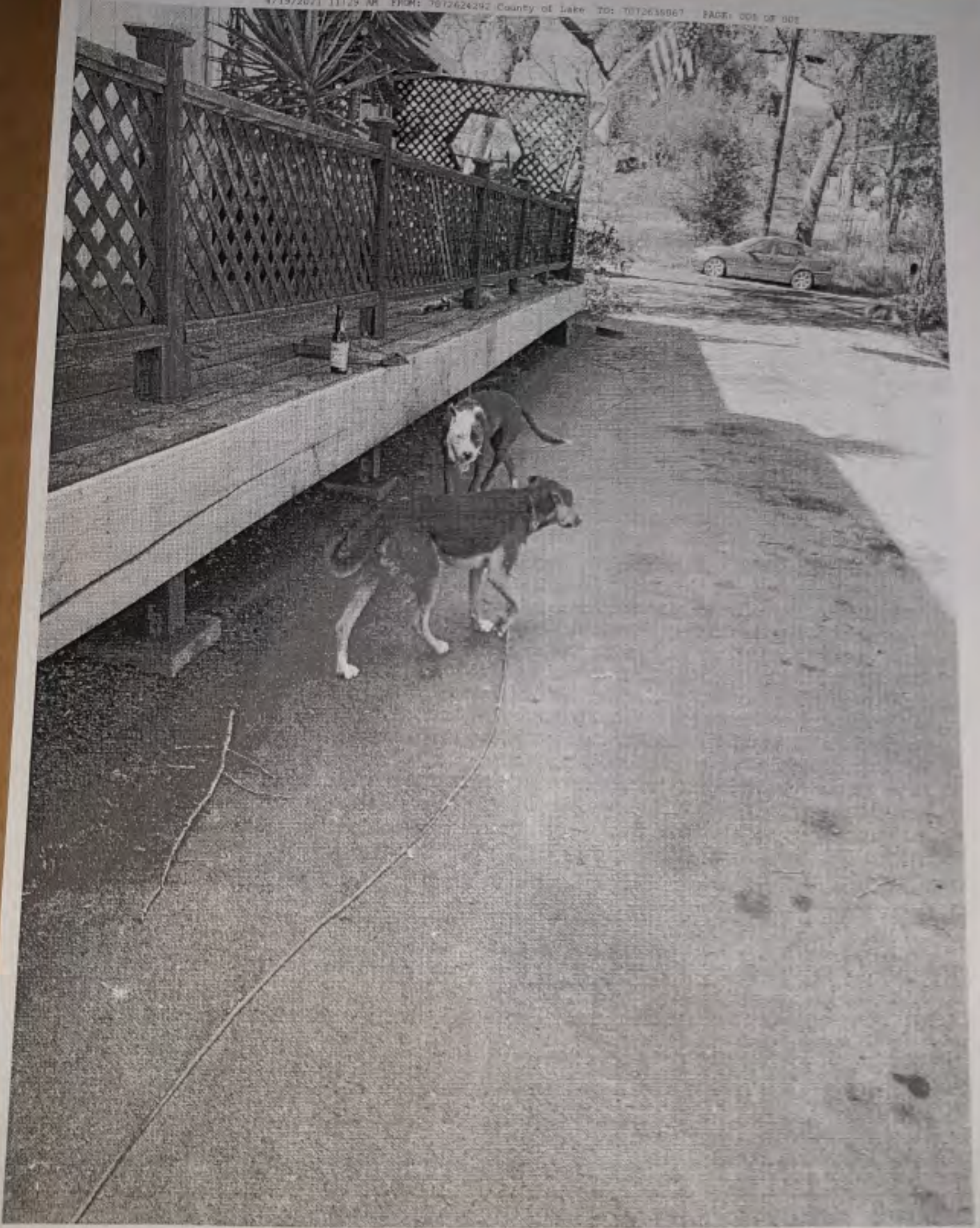
