COMMERCIAL CANNABIS ORDINANCE

In response to the adoption of the AUMA and MAUCRSA, commonly referred to as Proposition 64 and SB 94 respectfully, the City of Lakeport is exploring potential revisions to the Lakeport Municipal Code as it pertains to commercial cannabis:

- Cultivation
- Retail sales
- Processing/manufacturing
- Licensing/taxation

Background

Under SB 94, the State developed a regulatory structure for licensing the various uses associated with commercial cannabis. Local jurisdictions may pass their own regulations providing additional elements of local control. However, in accordance with SB 94 these local regulations must be in place by January 1, 2018.

For several months a Working Group consisting of two City Council Members and City Staff reviewed possible amendments to the City's Municipal Code. The primary focus of the Working Group aimed to balance the demand for commercial cannabis operations while at the same time limiting their visibility within the community and reducing potential negative impacts. The group's proposals were forwarded to the Planning Commission for review.

Public Input

The Planning Commission held a series of public meetings to take public comment and make recommendations. Efforts at outreach include a dedicated page upon the City's website on the topic (www.cityoflakeport.com) and an aggressive outreach campaign that has included press releases, newspaper articles, social media blasts and more.

The public is encouraged to attend and participate. All meetings will be held in the **Council Chambers at City Hall, located at 225 Park Street in Lakeport.**

EMERGENCY TELEPHONE NOTIFICATION SYSTEM

This is a reminder, in the light of recent local and regional emergencies, that the City of Lakeport maintains an emergency telephone notification system that is operated by the police department through **NIXLE**. All AT&T landline telephone numbers in the city are already connected to our **NIXLE** system.

Opt In to Receive Cell Phone, VoIP and Text Reverse 911 Notifications

We understand that many residents no longer maintain landline telephones but rather just use their cellular phones. Additionally, some residents and businesses use Voice over Internet Protocol (VoIP) phone services. We do not have access to VoIP or cellular telephone numbers in a format that can be obtained and loaded into our system in the same manner as the AT&T landline numbers.

However, residents can register their VoIP or cellular telephone numbers in our **NIXLE** system by logging into your account, or if you don't have an account, creating one here: <http://local.nixle.com/accounts/login/>.

1. Once logged, in go to the account tab and make sure your information and numbers are entered
2. Select where you want voice messages to go.
3. When completed with the account information, check your settings tab and make sure you are connected to the agency "Lakeport Police Department".

We are requesting that all residents and businesses make sure their numbers are registered with us. This is important for people to receive critical emergency information by telephone in the event the City or Police Department needs to send such information out by telephone.

FALL STREET SWEEPING SCHEDULE

MONDAYS - Clearlake Avenue to North City Limits.

Any streets in this area that might have been missed on Monday will be taken care of on Thursday.

TUESDAYS - First Street to south city limits including Esplanade area, Lupoyoma Heights, Lakeport Boulevard and Parallel Drive.

WEDNESDAYS - Second Street to Clearlake Avenue.

THURSDAYS - Additional Streets that may have been missed on prior schedule.

FRIDAYS - Main Street and Westside Park Road, and any areas needing special attention. Every other Friday they will not be running the street sweeper.

Blowing leaves into the street is acceptable, but please **DO NOT** put them in piles as the street sweeper cannot sweep up piles of leaves. We do encourage residents to utilize their green waste service.

This schedule will remain in effect for the Fall season only. This schedule is provided for the City of Lakeport within city limits and is on an "as needed" basis to maintain City streets during this time of year when leaves and debris accumulate in our streets.

Please be advised that there may be minor interruptions to the schedule from time to time due to City workloads and availability of manpower.



UTILITY BILLING REMINDERS

Payment Due Date

Utility Payments are "Due upon Receipt" of the bill and **must be received in our office by 5:30 p.m. on the 9th of the month** to avoid a late fee. Postmark date does not apply. If the last

payment date of the 9th falls on a weekend you will have the following Monday to pay without a late fee.

2017 FLOOD REPAIR PROJECTS UPDATE

The 2017 Flood Event in January and February resulted in damage throughout the City. The City experienced flood damage in neighborhoods along the lakeshore, including Library Park, as well as water intrusions into the municipal sewer system.

The City is working with FEMA for funding for restoration & recovery projects. The cost of these projects is approximately \$1.1 million. While these projects will unfortunately compete for resources with other disasters that have struck the State this year, the City is assured that the funds will be dispersed over time. These projects include:

- **Library Park Seawall Replacement:** Once funding is established, the seawall replacement will take place contingent on environmental mitigation issues as well as seasonal issues. Replacement is dependent on low lake levels to construct the new seawall. The fencing in Library Park will remain until the seawall is rebuilt.
- **The 3rd street Boat Ramp** is expected to be fully operational by Summer 2018
- **Sewer System:** Incursion of water into the Municipal sewer system has been capped, and the system is now in a better position to withstand a future catastrophic flood event.
